Description:

Our Barn was constructed in 2017 on the Bever family Homestead (1831).

The Barn sits on 110 rolling acres near a small pond and secluded road in Fayette County, Indiana. We are in Orange township near the Rush and Franklin County lines. Our venue is 50 miles east of Indianapolis and/or west of Cincinnati.

Our beautiful batten board-sided barn has a rustic feel that has modern amenities. Sliding barn doors on 3 sides of the building bring the outdoors inside.

A full front porch gives amazing views of our pond, farmland and a peaceful rural wooded setting.

We have a large full service kitchen for our in-house catering service equipped with a refrigerator for your needs and an ice machine.

Alcohol Policy with In House Bartending Service ONLY:

□ Fee to be paid directly to Bar Maids LLC no later than night before wedding or as agreed upon with Clare Cull.

EVENT Guidelines:

<u>Parking:</u>

- Parking is permitted in the designated grassy areas only. It is recommended that renter have 1 or 2 persons assigned to do parking duty.
- Parking in front of the barn and in the driveway is limited to drop off and pick up only. Thank you.
- NO PARKING DIRECTLY ON KITCHEN SIDE OF BARN AND DOOR This area is designated for FOOD DELIVERIES AND CATERERS ONLY

<u>Fire Safety:</u>

Please make note of the location of the fire extinguisher and communicate with your family and party members.

<u>*No Smoking OR vaping in the Barn or on the porch area, ONLY in the Designated Smoking area. Smoking area must be 10 feet away from the barn. Cigarette butts are you be disgarded in marked container. Thank you.</u>

**Please communicate your intent to use open flame candles in the Barn. Only the owner's being aware will allow for; bonfire, fireworks, sparklers, etc.

**We recommend your DJ or point person communicate before and during your event as reminders about the smoking policy.

In consideration to our Clean Up Crew it is essential also for good communication and understanding the party is over at Midnight. DJ's make an announcement and play the last song at the right time.

The Clean up Crew typically arrives between 11:00-11:30 to begin cleaning up.

Guest Care:

- □ No swimming, fishing or wading in the pond.
- Absolutely NO confetti at wedding sites or barn.

- □ No children under the age of 12 permitted in the loft without a parent.

- □ Renter and/or guest may not be in any other structure or area of the property than that approved of by Bever Barn.
